CONCEPT PAPER

PURPOSE OF THE BUSINESS FORUM:

Bulgaria will host the Three Seas Initiative in July 2021 as a logical continuation of our previous participation in this regional format. This initiative dates back to its launching in 2016 at the meeting of the Presidents in Dubrovnik, Croatia.

Following the established tradition of the Three Seas Initiative, the goals of the Business Forum as its integral part are:

- to promote the Three Seas Initiative as a tool for attracting new investments to Central and Eastern Europe in order to finance trans-regional and cross-border projects of strategic importance in the field of energy security and diversification, transport, and digital connectivity.
- to stimulate industrial cooperation and the establishment of direct business contacts between the business circles of the countries in the region in the field of innovation, new technologies and research in order to ensure conditions are in place for the full realization of better qualified and educated young people in the CEE region.
- to help establish a favourable investment and business climate based on the principles of the free market, transparency and competitiveness, in order to attract fresh strategic investment and private capital to the region.
